| <p>Which Training Course must I do?</p> | <p>According to the church of England guidelines everyone completes C0 once. For those requiring C1 training this must be completed every 3 years. However, in September 2016 the new training programme came into force so anyone who completed the previous modules 1 Safeguarding training will need to do the C0 training and then book on C1 if their role requires it. Once they have done this 3 years from the date of the C1 they would do the refresher course which is C5. This will not be out until September 2019.
